- Anhar Al-Deek and her fetus gain freedom.. The release of the detainee Anhar Al-Deek from the occupation prisons on a financial bail of 40,000 shekels and house arrest in her family's home.
- 6 detainees continue their open hunger strike in the Israeli occupation prisons.
- The cemetery of the living.. 12 sick Palestinian detainees are living in catastrophic conditions, as they face the policy of slow death in

- The Palestinian ambulance receives the wounded released detainee Abdullah Basem Abu Bakr at the Barta'a crossing and transfers him to Jenin Governmental Hospital after his release by the occupation after a month and a half detention.
- The occupation transfers the detainee Kayed Al-Fosfous, who has been on hunger strike for the 50th consecutive day, in refusal of his administrative detention from the isolation of the Negev prison to the isolation of Jalameh detention center to discourage him from continuing the strike.



- The health condition of the detainee, Alaa Ibrahim Al-Hams, from Rafah in the Gaza Strip, has deteriorated. He suffers from tuberculosis, pneumonia and shortness of breath. He takes 11 types of medication daily. He has been detained since 2009 and has been sentenced for 29 years.

- Including a pregnant.. 130 women have been arrested by the occupation in the occupied West Bank and Jerusalem since the beginning of this year.
- Including 73 minor children.. The occupation has arrested 1,000 Palestinians, including 230 children with special needs, in the occupied West Bank and Jerusalem, since the beginning of this year.
- The occupation prisons administration abuses striking detainees through repeated and systematic transfers, without the slightest consideration of their health condition, in an attempt to pressure and isolate them, and to obstruct lawyers' visits to them.
- The victory of the will.. The detainee Ahmed Hamamra from Bethlehem suspends his open hunger strike, which lasted for 33 days, after an agreement to release him on February 14th.
- The health condition of the detainee, Alaa Al-Araj, who is on hunger strike for the 30th consecutive day, has deteriorated. He suffers from general weakness in his body and is unable to stand. He lost nearly (30 kg) of his weight after continuing his hunger strike.

- Warnings about the worsening health condition of the young detainee Yassin Imad Shbeita, 19, from the village of Azzun, east of Qalqilya. He suffers from nerve and heart problems, and he has been paralyzed in his left foot and hand for nearly two months. Signs of swelling appear on his hand, and he cannot move it at all.
- Transferring the detainee, Wafaa Kundus, from Al-Jalameh interrogation center to Rambam Hospital in Haifa, after her health deteriorated.

- The Israeli occupation prisons administration continues the solitary confinement, in difficult sanitary conditions, for each of the following detainees:

- The death of the former detainee and university lecturer, Professor Issam Al-Ashqar, after a struggle with illness.
- The Military Occupation Court sentences the detainee, Sanad Turkman, from Jenin, to 47 months in prison, in addition to a fine of 10,000 shekels.

- Detainees continue their open hunger strike in refusal to administrative detention in Israeli occupation prisons:
