- The detainee, Kayed al-Fasfous, from Dura, south of Hebron, is enjoying his freedom after a year and a half detention, knowing that he went on a hunger strike for 131 days in order to refuse his administrative detention.
- Detainee on hunger strike Hisham Abu Hawash: "My health is poor and I have become very thin. I will not go back on my strike even if I am martyred, and I say to my wife: I hope you will keep the covenant and protect yourself and the children, and I will not forgive anyone who has failed me and I will argue with him before God."
- The detainee, cancer patient, Nasser Abu Hamid, was transferred to Barzilai Hospital in Ashkelon, in a poor health condition, as he suffers from the consequences of a lung cancerous tumor, he underwent last October.
- The Israeli occupation prisons administration is delaying in setting a date for the release of Sheikh Raed Salah, who is being held in solitary confinement in Hashikma Prison in Ashkelon.



- After 49 days of the strike, the detainee Louay Al-Ashqar from Tulkarm suspended his open hunger strike after an agreement with the occupation authorities to limit his administrative detention.
- The victory of the will... The detainee, Nidal Ballout, from Bani Naim, suspended his hunger strike after 31 days.
- The International Foundation for Solidarity with Palestinian Prisoners (Tadamon) signs a cooperation agreement between the Ministry of Women's Affairs in Gaza, coinciding with the International Day of Solidarity with the Palestinian People.
- Elderly detainee Fouad Al-Shobaki was suddenly transferred to the Israeli "Soroka" hospital, which was later returned.
- The Secretary-General of the PFLP, the detainee Ahmed Saadat: "Any support for the cause of our detainees must be based on its political dimension, work and struggle for the internationalization of their cause."
- The occupation arrested 365 Palestinians, including 42 children and 8 women, during the month of November, and the courts issued 87 administrative detention orders during the month of November.
- The occupation releases Sheikh Najeh Bkirat on the condition that he be removed from Al-Aqsa Mosque for 20 days and from the West Bank for 30 days.
- The occupation prisons administration continues to refuse to provide the necessary treatment to the detainee Hudhayfa Badr Halabiya from the town of Abu Dis, east of Jerusalem; He suffered

- a broken leg two weeks ago, after he fell in the yard of "Ofer" prison. The prison administration did not provide him with any treatment other than painkillers and a crutch, and refused to transfer him to the hospital.
- The occupation prisons administration continues to refuse to provide the necessary treatment to the detainee Hudhayfa Badr Halabiya from the town of Abu Dis, east of Jerusalem; He suffered a broken leg two weeks ago, after he fell in the yard of "Ofer" prison. The prison administration did not provide him with any treatment other than painkillers and a crutch, and refused to transfer him to the hospital.
- The family of the detainee, Eman Al-A'war: Our mother suffers from severe pains in the thoracic cage, and her health condition is deteriorating due to medical neglect, as she needs periodic and continuous check-ups.
- Head of the Investigation Committee of the Freedom Tunnel Operation: "The lack of knowledge of the prison intelligence service about digging a tunnel in Gilboa prison over a period of 9 months is what worries us the most."
- The Occupation Court in Ofer rejects the request to appeal the administrative detention decision against MP Khaled Ibrahim Tafesh from Bethlehem, which means renewing his administrative detention, knowing that he has been in detention for a year.
- Jerusalemite detainee Ameen Shwiki continues his strike for diabetes treatment for the 79th consecutive day in protest of his administrative detention.
