- The captive movement: a state of escalation and boiling in the occupation prisons, which it has not witnessed for a long time. We face this escalation with a unity that has never been seen before, and it will not stop until the prison administration stops its repressive measures against us.
- The mother of the sick detainee Nasser Abu Hamid: "Nasser is currently living in a coma after his health deteriorated as a result of the presence of water in his lungs, during his recovery period for days he was completely paralyzed and was sitting in a wheelchair for a period not exceeding a week, in which he lost his memory and was unable to identify anyone."

- Zaher Jabareen, The member of the Hamas Political Bureau: "The occupation is procrastinating the exchange of detainees, and there were two opportunities to accomplish it, but the occupation was not serious, and we stress that resistance in all its forms will not allow detainees to suffer inside the prisons of the occupation, and we are watching, moment by moment, everything that is going on inside the prisons."
- Detainees Authority: "The occupation imposes policies of movement, isolation and inspections on a continuous basis and with dangerous escalatory measures against detainees in prisons, and its administration refuses to respond to their demands."
- Ofer Military Court renewed the administrative detention of the detainee Ahmed Hamamra from Bethlehem for a period of 3 months for the fourth time in a row. He has been in detention for 18 months, and last year he went on a hunger strike that lasted 33 days to reject his administrative detention.
- The longest trial in history.. The Israeli occupation court in Jerusalem postponed the trial of the detainee Muhammad Al-Halabi from the Gaza Strip for the 168th time until the next session is scheduled.
- The martyrdom of the freed detainee, Nihad Al-Barghouti, from the town of Kafr Ein, after he was shot by the occupation during the confrontations in the village of Nabi Saleh northwest of Ramallah.

- The Israeli "Raymond" prison administration transfers detainee Ayman Haj Yahya to solitary confinement and imposes severe penalties on him, including preventing visits and participation in the break.
- Sick administrative detainees in Israeli occupation prisons decide to refrain from taking medication as an escalation step to confront and boycott the occupation courts.
- Ofer Court sentences the detainee, Khitam Ismail Al-Saafin, 60 years, from Ramallah, with an actual prison sentence of 16 months, She has been in administrative detention for 15 months, and only 4 months will be counted from her administrative detention against which an indictment was filed, in addition to a fine of 1,500 shekels.
- The occupation transfers the detainee Qassam Saber Hammad from Qalandia camp to Al-Ramlah prison hospital after being infected with the Corona virus, knowing that he has been detained for two months and has been hit by a bullet to the head and shrapnel during previous confrontations.
- The occupation forces blew up the house of the detainee Mahmoud Jaradat in the town of Al-Silah Al-Harithiya, west of Jenin.
- Wafaa Jarrar, wife of detainee Abdul-Jabbar Jarrar: The occupation soldiers barbarically stormed the house and tried to arrest him from his bed without allowing him to change his clothes despite the cold weather and his suffering from several diseases.
- The Israeli military court sentences the detainee, Ismail Muhammad Nasr, from Dura, Hebron, to two years in prison and a fine of 2,000 shekels.
- Jerusalemite detainee Ameen Shweiki continues his strike for diabetes treatment for the 156th consecutive day in protest of his administrative detention.
